- Membership in The Transportation Alliance is on a calendar-year basis, beginning on January 1 and ending on December 31.
- With the exception of 20% of your dues used for lobbying Congress and federal regulatory agencies, The Transportation Alliance membership dues may be deducted as a business expense but not as a charitable contribution under U.S. laws.
- Final acceptance of membership is based on approval by The Transportation Alliance board of directors.
- Companies must join by March 1 to be included in the print *Buyers' Guide*.
